- 5. Presentation and Adoption of Annual Reports
 - a. President's Report (Elizabeth Banfalvi) Elizabeth talked about the significance of the fact that our products from the group are the anthologies and there were 3 last year with the Word Fest, Canada, our Home and Celebrating Canada 150. Our members had a lot of activity attending city events to promote and have youth and adults writing what they loved about Canada which was used in the anthologies. We also collaborated with 2 schools for the first time Philip Pocock CCS and St. Elizabeth Seton CES and this was originated through Studio 89 and the Third Monday Group. We had monthly speakers all through the year as per a survey the group did and requested over a year ago. This has been very successful and has brought in numerous people to speak to our group. Sheila Van Den Heuvel-Collin took over our e-zine in May 2017 and it is now called "Write On!".
 - b. Marketing and Communications Committee Elizabeth spoke about Facebook and the significance of Michelle and Paul Costa and their activities in the poetry slams locally and in Toronto and Oakville. This has opened up new venues for our writers and it has built their confidences in their own work. Kyle still replies to Facebook messages for our group.
 - c. Program Committee (Michelle Hillyard) workshops, random anthologies Michelle spoke about the Free Workshop she presents before the meeting and how it has grown from 3 to 20 in attendance throughout the year. She asked the group to let her know what else they want presented so she prepares workshops that are relevant to what they want to hear. Michelle organizes the Random Acts of Poetry.
